Rideau Carleton Raceway (RCR) reserves the right to require five separate betting interests in the Final or the event may be declared off and all monies paid in by nomination payments shall be divided equally among those declared into start. RCR reserves the right to reject any entry and return fees, to declare the event off if conditions warrant, call off the event if there less than sixteen (16) nominations, and place in the correct classes if not entered correctly. In the event RCR cancels or delays the racing program(s) due inclement weather or any another cause leading to temporally disruption of the racing schedule, nominees and/or trainers will be notified regarding rescheduling or cancellation. RCR is not responsible for any inadequacies in the postal system for late nominations.

This event is conducted under the Rules and Regulations of the Ontario Racing Commission and RCR.

Purse distribution – 1st 50% - 2nd 25% - 3rd 12% - 4th 8% - 5th 5%.

All races will be raced at a distance of 1 mile.
