The NCRHHA and RCR are holding exhibition races for young people who do not hold a driver's license. There will be races for both males and females.

- ❖ Entry forms can be found at the NCRHHA office, the RCR paddock and the NCRHHA website. Please submit your completed entry form to Sharla Daley or Sharon Christie in the NCRHHA office on or before **July 1, 2010**. (We realize that the availability of particular horses may change but please do your best to provide us with the name of the horse you will be driving.)
- ❖ If we have enough trotters there will be a trot race.
- ❖ Races will be classified based on ability of both horse and experience level of the driver.
- ❖ Horses will be cheaper and conditioned claimers or very low level condition performers.
- ❖ There will be a program printed so the entry form must be complete.
- ❖ The NCRHHA reserves the right to refuse any entry.
- ❖ Distance is 1 mile.
- ❖ Whips are not permitted.
- ❖ Tattoo numbers may be checked.
- ❖ *Note: All participants are responsible for the horse they are driving from the time it arrives on the premises until it leaves. This includes harnessing, warming up, bathing, etc.*
